Minimum Qualifying Criteria:

- 1) Tender document fee Rs.590/- and EMD amount Rs.37,500/- shall be submitted through online payment on www.mahatenders.gov.in. Details of UTR no. should be uploaded online.
- 2) The bidder must have successfully completed the projects as below, during the last 05 financial years ending upto bid submission closing date. The bidder is required to submit its Work Order and Completion Certificate issued by the Clients.
 - 03 similar types of works whose estimated value is not less Rs.15 Lakhs each.
OR
 - 02 similar types of works whose estimated value is not less than Rs.18.75 Lakhs each.
OR
 - 01 similar type of work whose estimated value is not less than Rs.30 Lakhs.
- 3) The bidder should have a maximum turnover of at least Rs.1.12 Crores, in any one year of the last 05 financial years (FY-2020-21, 2021-22, 2022-23, 2023-24 & 2024-25). Profit & Loss statement and CA certificate should be attached along with technical details.
- 4) The bidder should be registered with Employees Provident Fund Organization. The copy of registration should be attached.
- 5) The bidder should have sufficient number of technical staff for the proper execution of the contract. The bidder should submit a list of these employees stating clearly who will be involved in this work, if work is awarded.
- 6) The bidder should submit the list of plants and construction equipment's required for the proper execution of the work.
