- 2) Also Bidder can upload the tender document by filling the prices after making the payment against EMD Rs. 50,00,000/- (Rs. Fifty Lakh Only) through online on www.mahatenders.gov.in website.
- 3) any bid not accompanied by an acceptable proofs of paid of both, Bid Security (EMD) and Tender Fees,
 - (1)- uploaded scan copies with technical bid on www.mahatenders.gov.in &
 - (2)- also submission of this scan copies in a separate sealed envelope shall be rejected by the owner / authorized representative as being non – responsive and returned to the bidders without being opened.

- 5) Bid Validity Period are **180 days** from the date of opening of Techno-Commercial Bid.
- 6) Bidder shall meet the qualifying requirement stipulated hereunder:

6.1 Technical Eligibility Criteria (TEC) :

- a) The bidder should have designed, supplied, erected and commissioned on turnkey basis of ground mounted Solar Photo Voltaic (SPV) based grid connected solar power plant(s) of **10 MW or 2 X 5 MW or 5 X 2 MW or 10 X 1 MW (10 MW cumulative)** or above installed capacity in India in the last five years from the bid due date.
- b) The reference solar PV plant of 10 MW or 2 X 5 MW or 5 X 2 MW or 10 X 1 MW (**10 MW cumulative**) or above capacity must have been in successful operation for **at least 12 months** up to the bid due date.
- c) The bidder should be presently in the business of Operation & Maintenance (O&M) of solar PV plants and should have the experience of successful operation and maintenance of solar PV plant of **10 MW or 2 X 5 MW or 5 X 2 MW or 10 X 1 MW (10 MW cumulative)** or above capacity in India for a period of **at least 12 months** up to the bid due date.

6.2 Financial Eligibility Criteria (FEC) :

- a) **The minimum average** annual turnover of the Bidder in the preceding 3 (Three) financial years as on bid issue date should be at least **INR 60 Crores (Indian Rupees Sixty Crores only). Financial Years :- 2015-2016, 2016-2017, 2017-2018**
- b) EPC Contractor should be in profits in last three years.
- c) The Net Worth for the last year should be **positive**. Net worth of the bidder shall be calculated as under:

Net Worth = Paid up share capital

Add: Free Reserves and surplus

Subtract: Miscellaneous Expenditures to the extent not written off and carry forward losses

Subtract: Intangible Assets.

Paid up share capital will include:

- Paid up equity share capital
- Fully, compulsorily and mandatorily convertible preferential shares
- Fully, compulsorily and mandatorily convertible Debentures.
- Share premium will form an integral part of the net worth provided it is realized in cash or cash equivalents. Other income shall not be considered for arriving at annual turnover.

Free reserves: means reserves created out of profits and securities premium account but does not include reserves created out of revaluation of profits, write back of depreciation and amalgamation or any capital reserve. Securities Premium will be considered to be part of net worth only in those cases where it has been realized/received in the form of cash. However, this may not be applicable in case of listed companies.

6.3 Land Arrangement Criteria (LAC) :

The bidder should identify **suitable Class I private land of minimum 50 Acres flat land having high solar radiation (5 - 6 kWh / m² / day)** required for installation of the solar power project in any solar potential region in Maharashtra State in India. The offered land should have clear title and free from any encumbrances, encroachments or litigation. The bidder should have any of the following arrangements for having the land:

1. Bidder already having possession of suitable private land in his own name. Also furnish the location of land with the bid. **OR**

The bidder should have an registered Agreement/ registered MOU with landowner and Submit the relevant document with the bid. or The bidder should have an registered Agreement with a third party (an individual or company) **OR**

Bidder's subsidiary or Bidder's group company who is/are either in possession / having registered Agreement to Sell (ATS) with owner of private land along with commitment to transfer such land to SSSTS without any consideration from SSSTS.

2. The successful bidder should transfer the selected land in the name of SSST Shirdi within one month from the date of issue of LOA and submit all land documents to SSST Shirdi. Failure of transfer of land by successful bidder in the name of SSST Shirdi within one month from date of issue of LOA the entire EMD amount will be forfeited and LOA stands cancelled.

3.

It is mandatory to submit the self-certified Certificate of bidder with Technical Bid about concerned land having solar radiation norms are (5 - 6 kWh/m²/day) suitable for installation of the solar power project. **Solar radiation analysis file should be carried out by METEONORM software and compulsorily submit along with this certificate. (The format of the Certificate is provided in Tender Document).**


6.4 General:

The bidder or its Proprietor/Partner(s)/Director(s) of the Firm should not have been convicted by a Court of Law for an offence involving moral turpitude in relation to business dealings during the past seven (7) years. The bidder shall give an affidavit to this effect. The affidavit must be affirmed before the competent judicial authority or duly notarized by the Notary. Besides, bidder should furnish litigation history of their firm or group firm (if claiming fulfillment of BEC on group entity terms). The litigation history shall include:

- (i) Court cases / Arbitration cases.
- (ii) Disputed incomplete works.
- (iii) Pending civil cases against the firm and/or its Proprietor/Partner(s)/Director(s) involving moral turpitude in relation to business dealings.
- (iv) Pending criminal cases against the firm and/or its Proprietor / Partner(s) / Director(s) involving moral turpitude in relation to business dealings.
- (v) Punishments awarded under civil cases and/or criminal cases involving moral turpitude in relation to business dealings to the firm and/or its Proprietor/ Partner(s)/ Director(s).

Note:

- a) The bidder should meet all the above eligibility criteria as on the bid due date. The bids of only those bidders, who meet the Bidder's Eligibility Criteria, will be considered for further evaluation.
 - b) Bidder shall submit, in support to the above, the list of projects commissioned along with copy of their work order (s) / LOA and the commissioning certificates issued by concerned State authorities.
 - c) The bidder shall furnish documentary evidence by way of copies of Contract / Purchase Order, Work Order, Completion Certificate, Commissioning Certificate, JMR by State Utilities or any other equivalent document, certificates issued by client or state authorities, Audited Annual Reports, Balance Sheet and Profit & Loss Account etc. of previous three years along with the Bid to establish experience / track record and financial capabilities meeting Bidder Eligibility Criteria of bidders.
 - d) In case the bidder is not able to furnish its audited financial statements on standalone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder furnishes the following documents for substantiation of its qualification.
 - Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the audited consolidated financial statements of the Holding Company.
 - A Certificate from the CEO/CFO of the Holding Company, stating that the unaudited unconsolidated financial statements form part of the Consolidated Annual Report of the company.
 - In case where audited results for the last preceding financial year are not available, certification of financial statements from a practicing Chartered Accountant shall also be considered acceptable, provided the bidder provides the detailed Financial Statements certified by the Management of the company.
7. As per SSST letter to MSEDCL with Ja. no. SSST/Vidyut/468/2019 dated May 11, 2019 for SSST Shirdi Meter Aggregation, EPC contractor shall design the solar plant accordingly.
