- 36) The manifold & control panel with pipeline and other tested for proper functioning every six months and repair should be done whenever necessary free of cost.
- 37) The supplier should install and commission the Oxygen Generator Plant with all accessories like filters, Controller, starter, manifold etc. To supply the Oxygen Gas as per user's requirement up to the hospital Gas manifold and the required standard pipeline, gauges, regulator, valves etc. Should be installed to connect Gas supplier to hospital manifold at supplier cost to be
- 38) The selected firm for supplying Oxygen Generator Plant shall have to install the Oxygen Generator Plant of appropriate size, and all high level safety standards matching to global standards NFPA / HTM/WHO at Sainath Hospital and will have to obtain the necessary License for the same (if any).
1. Oxygen Generator Plant should be certified for medical use as per IP (Indian Pharmacopoeia - 2010).
 2. Should have oxygen purity of minimum 90% & more with moisture of ≤ 60 ppm
 3. The quality certificate/s for manufactured oxygen should be provided by the firm. It should be tested for every six months within warranty & CMC period regularly.
 4. The firm shall liaison for the necessary explosives license if any on our behalf.

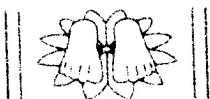

6. For uninterrupted supply of Oxygen Generator Plant, firm should have Service Engineer within 200 Km distance from shirdi.
7. Safety features like double audio visual alarm is mandatory for
 - a. Alarm- equipment failure.
 - b. Alarm- Storage Tank low pressure and Back-up manifold in operation
 - c. Alarm- Hospital pipeline pressure low
- 39) Within warranty & CMC period, the Oxygen Generator Plant should be maintained for it's proper functioning with all required spare part, accessories and consumables if any by the supplier.
- 40) Breakdown call of Oxygen Generator Plant must be attended within max. 8 Hrs from the first report & stand by arrangement must be done time of Oxygen Generator Plant.
- 41) Scope of Work of Hospital:
 - Hospital has existing Central Medical Gas Plant & Oxygen manifold in clear area as per requirement, so supplier should install the plant in the same area.
 - Secured area for unloading and storage of Oxygen Generator Plant and accessories Coil during the installation phase.

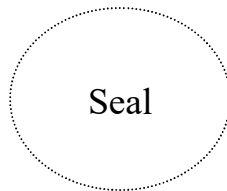
