Shree Saibaba Sansthan Trust, Shirdi invites quotation offers from eligible, reputed Internet Service Providers to enter into a contract for Supply, Installation, Integration & Commissioning of 50 MBPS (1:1) Internet leased line over OFC. The duration of the contract will be of **One year**.

Validity Period:

The offer of the bidder shall remain valid for acceptance for a minimum period of **60 days** from the date of submission of Quotation.

2.1 Scope of Work:

- 1. Visiting Location, checking feasibility of Optic Fiber cable up to Mux room of above given address.
- 2. Supply, Installation, Integration & Commissioning of 50 MBPS (1:1) Internet leased line over OFC at M/s. TCS, Hitech City Rd, Cyberabad.
- 3. Maintaining 99.99% uptime during contract period.
- 4. The successful bidder should provide 24X7 supports within contract period.

3.0 TENDERING PROCEDURE.

Qualification Criteria:

- 1) Bidder must be Category "A" or "B" ISP (Internet Service Provider). The bidder must have a valid class 'A' or 'B' category license from DoT, M/o CIT, Government of India.
- 2) Bidder should not be blacklisted by any Central / State Government or Government Corporation, Statutory Institute.

3.1 Technical Bid

- 1. PAN, GST Registration.
- Copy of document showing ISP License No. (with date) along with a copy of the License Agreement for the provision of Internet Service issued by Government of India/TRAI/DoT to be enclosed.
- 3. Bidder's self-declaration on letter head stating that "Firm/Company is not blacklisted by Central/ State Government or government corporation, statutory Institute" format is attached in Annexure E.

- 4. Undertaking on letter head of Firm/Company Stating that "Company/Firm have read all terms and conditions and agree with it."
- 5. The bidder must have single fully functional Customer Service Centre(s)/Contact Support Centre with 24 X 7 X 365 support. List of Customer Service Centre(s) and escalation matrix must be enclosed with technical bid.

- 2. ISP have to submit quarterly invoice **after completion of quarter**, which will be paid by Sansthan on the basis of SLA.
- 3. Hardware Charges: Any Hardware if required for commissioning of this link will be provided and maintained by the successful bidder (ISP) at its own cost.

5. Terms and Conditions:

- 1) The bidder should have fully resilient and self-healing networking architecture on fiber medium for domestic backbone up to international gateway in India.
- 2) The bidder should have solution for future scalability of bandwidth.
- 3) The bidder would insure that the local loop provisioning does not violate regulations as laid by Government of India/TRAI in respect of such links/networks. Bidder will be responsible for making all the payments towards the local loop charges/rentals charges etc.
- 4) Liaising (if required) with other Category "A" or "B" ISP (s) for obtaining connectivity between ISP node and TCS mux room shall be the responsibility of the bidder.
- 5) The decision of Chief Executive Officer, Shree Saibaba Sansthan Trust, Shirdi will be final and binding in case of any dispute between Trust and the bidder.
- 6) The bidder should study all the tender documents carefully and understand the tender contract conditions, specifications etc. before quoting. If there are any doubts, they should get clarifications via phone call or email, but this shall not be a justification for submission of late tender or extension of submission date.
- 7) Shree Saibaba Sansthan Trust, Shirdi reserves the rights to Accept / Reject Partial / Full Tender.
- 8) The bidder must be ready to relocate if needed, with minimal relocation charges.
