(1) Introduction:

- 1.1) Interested eligible Tenderer may obtain further information of Scope of Work, technical specification of the system, required spare parts, consumables & accessories quantities and other terms and conditions applicable for CMC of Cathlab System from Shri Saibaba Sansthan Trust, Shirdi for E-tendering on website: <http://www.mahatenders.gov.in>
- 1.2) All tender related activities (Process) like Tender Document Download, Tender Preparation, Tender submission and Transfer of EMD and other documents will be governed by the time schedule.

(2) Cost of Bidding

- 2.1) The tenderer shall bear all costs associated with preparation and submission of their online tenders and Sansthan will not be responsible for expenses of tenderer whether the tender process conducted / completed or not.
- 2.2) At any time prior to the deadline for Sale of tender, the Purchaser may amend the tender documents by issuing Addendum/ Corrigendum.

(3) Prices:

- 3.1) The rates are to be given for CMC of Cath LAB Machine must be for F.O.R. Shirdi inclusive of G.S.T., duties, transportation, if it is not mentioned clearly your quoted rates will be treated Inclusive of all taxes and duties etc. No extra amount will be paid for packing, forwarding, transportation, lodging, Travelling and taxes etc. No escalation will be allowed in the quoted price for any reason.
- 3.2) You must fill-up the commercial part as per BOQ, in the column of Rate you must give Basic Rate + GST, etc. & in GST column you must give exact GST % applicable for that particular product.
- 3.3) You have to deposit the amount of EMD & Tender Form Fee directly online to www.mahatenders.gov.in. There no exemption for any certificate or firms registers.

- 3.4) Rates for CMC should be quoted in Indian Rupees for next 5 Years as per the format of price schedule. And no increase will be given or allowed in the rates for any reason whatsoever, till the contract period.
- 3.5) If at any time during the period of contract, the price of CMC is reduced or brought down by any Law or Act of the Central or State Government or by the tenderer himself, the tenderer shall be morally and statutorily bound to inform the Purchaser immediately about such reduction in the contracted prices. The Purchaser is empowered to reduce the rates accordingly from same day. If the tenderer refused to oblige, the purchase order, contract agreement shall be cancelled and the Security Deposit shall forfeited.
- 3.6) Where ever the amount is mentioned in figures, it must be mentioned in words also.

(4) False Clause:

- 4.1) You have to give self-affidavit regarding the firm has not been found guilty of malpractice / misconduct / black listed / debarred either by Public Health Dept., Govt. of Maharashtra or by any local authority and other State Govt. / Central Govt. Organization in past three years for the quoted items in the Tender. You have to further confirm that you will quote for CMC of Cathlab Machine system (Make- Shimadzu, Model- Bransist Alexa F12 Mix Package). And also declare that you are not providing service CMC for Cathlab Machine system (Make- Shimadzu, Model- Bransist Alexa F12 Mix Package) to any other Institution / Hospital in India below than the rates quoted in this Tender or Also follow the guideline not higher than MRP& supply only Branded Material.

If rates quoted are more than the rates already given to any other Institutes / Hospital in India, the reasons thereof should be mentioned in Annexure II.

- 4.2) It is found that the tenderer has submitted false affidavit in Annexure II, the purchase order shall be cancelled and Security deposit shall forfeited & Tenderer may be blacklist.

(5) Security Deposit & Contract Agreement:

- 5.1) The EMD shall be forfeited:

- a) In case the purchaser found that tenderer has quotes prices higher than any other hospital of India.
- b) Tenderer fails to accept the purchase order.
- c) If a Tenderer withdraws its tender during the period of bid validity as specified in the Tender.
- d) In case of a successful Tender, if the tenderer fails to provide the services as per tender clause.
- e) If tenderer refuses to sign the Contract as per terms and conditions of Sansthan agreement.
- f) If tenderer fails to furnish security deposit.

- 5.2) The successful tenderer will have to **deposit 3% security amount** of the total cost of the Work order which will be refunded after six months from the date of Completion of CMC period.

- 5.3) The tenderer commercial bid must remain valid for a period of 120 days from the last date of submission of bid. A commercial bid quoted with validity less than above will be rejected.
- 5.4) Prior to the expiration of the bid validity, the Purchaser may request the tenderer to extend the bid validity for the period as required by the Purchaser.
- 5.5) No interest will be paid on Earnest Money Deposit / Security Deposit.

(6) Technical Terms:

- 6.1) The tenderer should mention address of its nearest service center & details of service Engineers with contact details and with all required Tools & Tackles. Also, in case of CAMC, he must give assurance in writing to provide all required spare parts from OEM and original as per the machine specifications whenever required till the end of CAMC period. Repaired or refurbished spare parts, accessories & consumables are not allowed to use at any condition. Service provider will replace the parts only after checking of spare parts for quality by Biomedical Engr.
- 6.2) Tenderer can visit for the inspection for Cathlab and all necessary parts, modules.
- 6.3) The CMC includes the Tube of the Cath Lab, spare parts & all consumable if any. Under this contract all parts, consumables and Labour will be given free of cost.
- 6.4) In case any material/ spare parts/ consumable is found to be faulty /substandard or not compatible to the Cathlab (Make – Shimadzu; Model: Bransist Alexa F12 Mix Package Cathlab Machine), during the course of use, then it is responsibility of supplier to exchange this material without any cost.
- 6.5) Only Original Make Spare parts & Consumable, accessories will be accepted. So, tenderer have to supply original spare parts & accessories only for CMC.
- 6.6) The Company must provide safety guidelines to be taken during handling & cleaning of machine for better operation and to avoid breakdowns due to mishandling or failure of machine due to rats and insects etc.
- 6.7) The tenderer should mention address of its nearest service center and details of service engineers with contact details and with all required tools and tackles. Also, in case of CMC, he must give assurance in writing to provide all required spare parts & consumables as per the machine specifications whenever required till the end of CMC period.
- 6.8) You have to execute Preventive Maintenance as per schedule provided in CAMC work order. During PMS visit if machine goes in breakdown by service providers Engineer, then, it must be made functional at company's cost.
- 6.9) Where ever possible, the service provider must provide the online remote service to keep the machine functional.

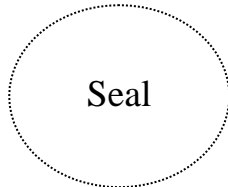
