#### ❖ Minimum Qualifying Criteria :

- 1) The bidder should submit the cost of blank tender document Rs.590/- and EMD of Rs.9,500/- through online payment on [www.mahatenders.gov.in](http://www.mahatenders.gov.in)
- 2) The bidder should be registered as a contractor with PWD or any other Govt. dept. in appropriate class. The registration copy should be attached.
- 3) The bidder must have successfully completed the projects as below, during the last 05 financial years ending 31<sup>st</sup> March 2024. The bidder is required to submit its Work Order and Completion Certificate issued by the Clients.
  - 03 similar types of works or civil works whose estimated value is not less than 40% of the estimated amount of the project / tender. (i.e.- it shall more than Rs.3.78 lakhs each).  
OR
  - 02 similar types of works or civil works whose estimated value is not less than 50% of the estimated amount of the project / tender. (i.e.- it shall be more than Rs.4.73 lakhs each).  
OR
  - 01 similar type of work or civil work whose estimated value is not less than 80% of the estimated cost of the project / tender. (i.e.- it shall be more than Rs.7.57 lakhs).
- 4) The bidder should have a maximum annual financial turnover of at least Rs.7 lakhs, in any one year of the last 05 financial years, (FY-2019-20, 2020-21, 2021-22, 2022-23 and 2023-24). The bidder shall submit the certificate issued by the CA.
- 5) The bidder should be registered with Employees Provident Fund Organization. The copy of EPF registration should be attached.
- 6) The bidder should be registered with GST Dept. The copy of GST registration should be attached.
- 7) The bidder should submit undertaking that he is not barred / not blacklisted by any Client including State / Central Govt. Department / PSU's.
- 8) The bidder should submit his Arbitration / Litigation record. If the bidder has no such record, he should submit an undertaking accordingly.
