

## Terms & Condition

1. The supplier should be manufacturer of Stainless steel industrial kitchen equipment & furniture.
2. All sheet, pipe used should be stainless steel 304 quality polished or matt as specified and thickness as specified.
3. The item shall be checked for nickel contains of stainless steel pipe & sheets used in the product. And if found not to the specification (i.e. 8%) the final payment shall be held up and the strong action shall be taken against the vendor. Shri Saibaba Sansthan has reserved the right to check the kitchen equipment material piece at any govt. approved metallurgical laboratory if required. The utensils and seats used in the items shall have of 1% nickel minimum. If found less than 1% necessary action will take against the vendor
4. The final tender cost should be included with supply & fabrication of each individual unit, it to be included in final cost as well as material details with loading, unloading etc. to be inclusive and GST inclusive.
5. Insurance & Transportation will be arranging by the vendor at their own cost. In case any damages caused to the equipment, during the transportation, loading, unloading fabrication the same shall be repaired & made good in accordance with their own cost.
6. All surface which come into contact with food product shall be free from crevices have a smooth finish. All joints should be well finished without any sharp corners.
7. No advance payment if any case would be made. 100% payment will be made after 15 days from the date supply of material at Shirdi Site.
8. **Time Period :-** The total material shall be supplied within 30 days from the date of purchase order.
9. The quotation shall submit in the sealed envelope. An envelope should be clearly attached & subscribed as "**Mechanical Department- Supply & Fabrication of SS Kitchen Equipment's**" The quotation in sealed envelope may be submitted to inward office of Shri Saibaba Sansthan on before dated **22/02/2025**
10. **Penalty :-** For delay for supply of material vendor shall be liable to pay the client as a penalty  $\frac{1}{2}\%$  of total order value per week. In any event maximum amount of penalty shall not exceed 5% of order value.
11. The equipment should be as per specification. No other technical specification will be acceptable. Duplicate, inferior material will be rejected by Sansthan.
