The devices should be provisioned for providing remote and automatic updates and upgrades from a centralized web based interface. The end users should not be able to uninstall this software or any application. The software will prevent the tablet from use by un-authorized user in case it is stolen and help in tracing the location. The Logo & message of the user Department for the users will be included in the Boot software so that it will appear on the Tablet any time it is switched on for use.
