Purchase of Sweeper Machines with accessories & Standby Battery

Online E-tenders are invited for the purchase of Sweeper machines with accessories and standby battery from manufacturers, authorized dealers. The tender details will be available on www.mahatenders.gov.in for downloading & the tender has view only access on the website of Trust www.sai.org.in under tender menu.

Validity Period:

The offer of the bidder shall remain valid for acceptance for a minimum period of 120 days from the last date of tender submission.

1.1 Scope of Work.

- Supply, installation, testing and commissioning of supplied sweeper machine as per specification.
- Provide product documentation, SOP, and operating training to SSST employees.
- Successful Tenderer has to send their technician Quarterly to inspect, adjust, rectify the machines, in warranty period.
- In addition to the Quarterly visit technician has to attend all breakdown call.
- Assurance to supply spare parts for next 10 years.

2.0 Tender Fee, Earnest Money Deposit & Security Deposit:

- a) Tender Fee: Rs:5,100 (Five Thousands One Hundred Only) and Earnest Money Deposit (EMD):Rs:85,000 (Eighty Five Thousands Only) should be paid online on the website www.mahatenders.gov.in
- b) Security Deposit (SD): Successful bidder has to deposit 3% amount of awarded cost as security deposit within 15 days from acceptance of purchase order. This SD amount will be refunded after warranty period of Sweeper machines.
- c) No interest will be paid on the EMD and Security Deposit.

- d) The successful tenderer will have to sign an agreement with the Sansthan on a stamp paper of Rs.100. The tenderer will have to pay the notary fee of the agreement.
- e) Exemption of non-payment of earnest money under MSME is not applicable to this tender. All tenderers are required to pay earnest money.

Note:

- 1. The amount of EMD will be refunded back to all bidders (except L1 bidder) after issuing purchase order to L1 bidder.
- 2. L1 bidder's EMD amount will be refunded after deposit of Security Deposit by bidder.
- 3. Even though the bidders meet the requirements, they are subject to be disqualified in case of misleading or false representations in the forms, statements and attachments submitted in proof of the qualification requirements.

3.0 TENDERING PROCEDURE.

3.1Technical Bid

Technical BID must submit online only.

Scanned copy of following documents must be uploaded as Technical-bid.

- 1. Latest Shop Registration Certificate/ Certificate from Local Self-Government Body/ Similar Government License in the name under which tender is to be submitted.
- 2. Certificate of GST Registration and PAN, in the name under which tender is to be submitted.
- 3. Authorized Dealer Documents/Letter from OEM.
- 4. Letter stating that the Firm/Company is not blacklisted by Central / State Government, Government Corporation, statutory Institute.(on firm letter head)
- 5. Sweeper machines Pamphlets/ Brochure along with model number and specification in comparison with model.
- 6. Letter on company/Firm letter head Stating that "Company/Firm have read all terms and conditions and agree with them"
- 7. Fill and upload the 'Annexure A, B and C.

3.2 Commercial Bid

- Quote Price should be inclusive of all Taxes, packing, forwarding, loading and unloading expenses, all accessories with machines, Installation and training cost.
- No other expenses will be paid separately by the Sansthan.
- ❖ In future, if there is change in GST then it will be make applicable from the date of notification.
- The Tenderer should quote online, in BOQ provided.

3.3 Acceptance of Tender:

- 1. Online Technical Bid will be opened on / /2023(If possible).
- 2. The commercial bid of technically qualified bidders shall only opened online and lowest offer (Set wise) amongst the opened bid will be accepted. The acceptance of tender will be communicated to the bidder by email or otherwise.
- 3. The quoted rates in online tender shall be valid for 120 days (Four Months) from the last date of the tender.

3.4 Warranty Period.

- 1. Warranty period of sweeper machines is 2 years from the date of commissioning.
- 2. Bidder should provide 24X7 online supports within warranty period. And should help our representative to log the call with respective company/OEM.
- 3. If supplier fails to resolve the issue in 48 hours from next business day, Rs.1000/- will be deducted per week from security deposit until the issue is resolved.

4.0 Payments:

- 1) No advance will be given for the said supply.
- 2)75% amount of order will be paid after supply, successful Installation/commissioning, of all sweeper machines.
- 3) 25% remaining amount will be paid after the training given to the sansthan employees and feed back of our Health Department.
- 4) Applicable taxes will be deducted at source from bills at the prevailing rate.

5.0 Penalty:

1. If the Machines & Batteries are not supplied per the supply order within the time limit, liquidated damages are recovered as follows.

a) If the cost of supply order 1 Rs.2.00 lakhs	less than	0.50% per week up to a maximum of $10%$
	s above	0.50% per week up to a maximum of 5 %

- 2 In case supply material is rejected because of it is not as per the supply order or not supply in specified time, the Sansthan shall be allowed to purchase the Machineries & Batteries from the market as per the market price and the excess amount (difference) for such purchased Machinery & Battery shall be recovered from the Security Deposit or subsequent Bills.
 - 3.It is mandatory to supply Machines & Batteries as per the sanctioned rate & Specification as per Supply Order. The supplier shall not have the right to ask for any increase in the sanctioned rate for any reason. Or such price hike will not be given. If the supplier refuses to supply the Machineries & Battery or does not supply the Machinery & Battery, the Sansthan has to purchase the Machines & Batteries at the market price and the compensation for the excess cost will be recovered from the Supplier. Also, the decision taken by the Sansthan will be binding on the Supplier. No complaint will be entertained in this regard.
- 4. If successful bidder refuses to deliver the sweeper machines or fails to deliver, EMD will be forfeited and bidder will be blacklisted for 3 years or the decision taken by the Sansthan will be binding on the supplier.

6.0 Terms and Conditions:

1. Sweeper machines registration with respective OEM should be done in the name of "Chief Executive Officer, Shri Saibaba Sansthan Trust, Shirdi".

- 2. The bidder should study all the tender documents carefully and understand the tender contract conditions, specifications etc. before quoting online. If there are any doubts, they should get clarifications in writing but this shall not be a justification for submission of late tender or extension of submission date.
- 3. The tenderer should not submit documents other than called in tender.
- 4. If you need any more information regarding the specification of tender materials or tender, please contact 02423-258771 /72.
- 5. Conditional tenders will be rejected.
- 6. Shri Saibaba Sansthan Trust reserves the rights to any changes ,amendments in the tender or accept / reject partial / Full Tender.

7.0 Delivery Schedule

- 1. Successful bidder should supply the machinery within 6 weeks from the purchase order acceptance date. Bidder should complete the Installation/commissioning/training within 01 weeks from the machinery delivery date. In total, bidder can manage the delivery and installation, commissioning, training 7 weeks from purchase order acceptance date.
- 2. Delivery of Sweeper Machines to be done at Store Department, Shri Saibaba Sansthan Trust, Shirdi on working day between 10 am to 6 pm.
- 3. Transport, freight and other charges will be bidder's responsibility.

8.0 Resolution of Disputes-

In case of any disputes between parties, the jurisdiction shall vest at Rahata and kopargaon court only.
