and also based on the detailed set of conditions, clarifications issued and additional stipulations made by the Sansthan.

The Quotation document is being invited on lump sum basis for ease of administration and management.

#### I. Technical Bid:

If any of the contents contained in this envelope do not meet the requirement of Sansthan, a note will be recorded accordingly by the Quotation opening authority and Commercial bid of the said bidder will not be opened and their EMD will be returned by the Sansthan.

#### II. Commercial Bid:

We will not use any explosives for demolition of the structures, all the works will be commenced by labours, machineries etc.

#### **GENERAL CONDITIONS OF CONTRACT**

#### **STRUCTURES TO BE DEMOLISHED:**

The quantity mentioned above is approximate and only indicative. The interested bidders can inspect the structures on all working days, except Sundays, during office hours.

- 1. The bidders shall demolish the complete structure including the foundation above the ground level, as per the instruction of the Engineer in-charge, dispose off the debris & other unserviceable material to the area to be defined by the bidder itself, with due permission of the local authorities, at their own cost.
- After accounting the cost of demolition, disposal of debris & unserviceable materials as above, the bidders / bidders shall quote the maximum amount that can be offered / given to Sansthan for the serviceable materials (Cost which can be recovered from Sale / Reuse of serviceable material such as Reinforcement Steel, Debris, FRP Sheets and Structural Steel, Trusses etc.).
- 3. The entire work is to be completed in all respects **within 7 days** from the date of handing over the possession of the site. The work shall be commenced within 7 days from the date of acceptance letter / work order issued by Sansthan or the date of handing over of site whichever is later.
- 4. The time is the essence of the contract and shall be strictly observed by the contractor.
- 5. The intending bidders shall visit the site and make him thoroughly acquainted with the local site condition, nature and requirement of the works, facilities for transport, nature of labour and machinery required, access and storage for materials and removal of wastes. The bidder should quote taking into account all the site conditions including traffic restriction for transport etc., for proper execution of the work.
- 6. The successful bidder will not be entitled to any claim of compensation for difficulties faced or losses incurred on account of any site condition.
- 7. The acceptance of the Quotation will be with Sansthan which does not bind itself to accept the highest Quotation and reserves to itself the authority to reject any or all the Quotations without assigning any reason. All Quotations in which any of the prescribed conditions are not fulfilled or incomplete in any respect, are liable to be rejected. Canvassing in connection with Quotations are strictly prohibited. Quotations submitted by the contractors who resort to canvassing are liable for rejection.
- 8. The contractor shall ensure the safety requirements laid down by the local authority and / or National Building Code. The contractor shall be responsible and he should indemnify the Sansthan for all injury / death to the workmen, to persons, animals, things, or any other damage to the surrounding properties which may arise from the operations, carelessness, accident or neglect of himself or of any of his workmen.
- 9. The Security deposit will be paid back to the contractor after receiving the complete credit amount quoted for the serviceable material, only after all the demolition work is completed and all the debris are cleared from the site to the satisfaction of the Sansthan within the stipulated period. If the work is not completed in all respects within the time schedule mentioned above, the Sansthan will forfeit the security deposit and terminate the contract.
- 10. After successful completion of the work Sansthan shall refund to the successful contractor the security deposit.
- 11. The demolition work shall be proceeded with in such a way that :
  - a) It causes no damage to the adjoining building and properties
  - b) It satisfies all safety requirements to avoid any accidents.

And nothing shall be paid on this account.

- 12. The bidder / contractor shall be fully responsible for the workers / staff engaged by them. They should be provided with adequate safety gears equipments, gadgets, and training, insurance, coverage. Relevant documents should be submitted during deployment.
- 13. <u>This is the lump sum auction bid invited for complete job work and includes all the cost required there in. The total amount of credit must be deposited with the Sansthan by the bidder at the time of acceptance of Work Order.</u>
- 14. This is a complete job of dismantling and demolition of the Welcome-Arch and including all the ancillary operations involved. i.e, the required materials, labour, machineries, tools and plants etc. for carrying out the demolishing work satisfactorily and safety. The dismantled obtained from the demolition will be bidders property and they will be free to take in away with him or dispose it. Land and external services are not included in this bid offer.
- 15. The Contractor in consultation with Sansthan shall take approval from the Police and other authorities all necessary that may be required by law & obtain all requisite permission for temporary obstructions, enclosure etc.
- 16. The work may be carried out in more than one shift or during night, no claim on his account shall be entertained. The contractor has to take permission from the police/ local authorities etc, if required for work during night hours, no claim/ hindrances on this account shall be considered if work is not allowed during night time.
- 17. The bidder shall study carefully, the specifications, schedule of quantities and conditions of the Quotation documents to fully appreciate the scope of the work before quoting his rates.
- 18. Safety Precautions and Emergencies:

#### 18.1 Contractor's Responsibility for Safety:

The contractor shall be solely responsible notwithstanding any stipulation by Owner for initiating, maintaining and supervising all safety precautions and programmes, in connection with the work and shall comply with all laws, ordinances, code rules, regulations and lawful orders of any public authority having jurisdiction for the safety of persons or property or to protect them from damages, injury or loss during the entire contract period including non-working hours

On the occurrence of an accident arising out of the works which result in death or which is so serious as to be result in death, the contractor shall within one hour of such accident intimate in writing to the Owner the facts stating clearly and in sufficient details the circumstances of such accidents and subsequent action taken by him. All other accidents on the works involving injuries to the persons or property other than that of the contractor shall be promptly reported to the Owner clearly and in sufficient details the facts of such accidents and the action taken by the contractor.

In all cases, the contractor shall indemnify the Owner against all losses or damages, resulting directly or indirectly from the contractor's failure to report in the manner aforesaid. This included the penalties or fines, if any, payable by the Owner as a consequence of failure to give notice under workmen's compensation Act or otherwise to conform to the provisions of the said Act in regard to such accidents.

In the event of an accident in respect of which compensation may become payable by the contractor, such sum of money as may, in the opinion of the Owner, be sufficient to meet such liability. On the receipt of award from the Labour commissioner in regard to the quantum of compensation, the difference in the amount will be adjusted.

#### 18.2 Warnings and barricades:

The contractor shall provide and maintain barricade, guards, guardrails, watchman, headlights and danger signals illuminated from sunset to sunrise, and all other necessary appliances and safeguards to protect the work, life, property, the public, excavations,

equipment and materials, barricades shall be of substantial construction and shall be painted such as to increase their visibility at night, for any accident arising out of the neglect of above instructions the contractor shall be bound to bear the expenses of defence of every suit, action or other legal proceedings, at law, that may be brought by any person for injury sustained owning to neglect of the above precautions and to pay all damages and costs which may be awarded in any such suit action or proceedings to any such person or which may the consent of the contractor be paid in compromising any claim by any such person.
