- 2) The bidder should be registered as a contractor with PWD or any other Govt. dept. in appropriate class. The registration copy should be attached.
- 3) The bidder should have satisfactorily completed atleast 03 works of similar nature of estimated cost not less than Rs.9 lakhs each, during last 5 years, ending on 28/02/2022.

OR

The bidder should have satisfactorily completed atleast 02 works of similar nature of estimated cost not less than Rs.15 lakhs each, during last 5 years, ending on 28/02/2022.

OR

The bidder should have satisfactorily completed atleast 01 work of similar nature of estimated cost not less than Rs.24 lakhs each, during last 5 years, ending on 28/02/2022.

- 4) The maximum annual financial turnover during last 05 years, ending on 31/03/2021 shall be min. Rs.45 lakhs. The bidder shall submit the Certificate issued by the CA.
