Payments and Penalty:

1. **Payment:**
 1. Payment will be made on quarter basis from the date of successful commissioning & acceptance of Link.
 2. ISP have to submit quarterly invoice after completion of quarter, which will be paid by Sansthan on the basis of SLA.
 3. Hardware Charges: Any Hardware if required for commissioning of this link will be provided and maintained by the L1 Bidder ISP) at its own cost.

3. The L1 Bidder should have fully resilient and self-healing networking architecture on fiber medium for domestic backbone up to international gateway in India.
4. The L1 Bidder should have solution for future scalability of bandwidth.
5. The L1 Bidder, would insure that the local loop provisioning does not violate regulations as laid by Government of India/TRAI in respect of such links/networks. L1

Bidder, will be responsible for making all the payments towards the local loop charges/rentals charges etc.

6. Liaising (if required) with other Category "A" or "B" ISP (s) for obtaining connectivity between ISP node and SSST Data Centre shall be the responsibility of L1 Bidder.
