EXPRESSION OF INTEREST

Shri Saibaba Sansthan Trust, Shirdi intends to facilitate Settingup NEET/JEE Classes for students of 11th and 12th Std. Through the above initiative SSST expects facilitation by way of inspiring young & bright students who can't afford migration to other urban cities & providing free education for the eligible ward of Shri Saibaba Sansthan Trust, Shirdi employees and at discounted rates for other civilians.

INTRODUCTIONS

Shri Sai Baba Sansthan trust Shirdi intends to start NEET/ JEE coaching classes for students of 11th and 12th standard at Shri Sai Dharamshala B wing. B wing consist of 32 halls which can be made available for study rooms,library, doubt clearing Centre etc. The main aim of establishing such project is to provide discounted education facility for the student of a rural areas who cannot affords to migrate to Urban centers. Such a project will also help the wards of employees of Shri Sai Baba Sansthan, Trust, Shirdi who will be get free coaching at this said facility.

ROLE OF THE INSTITUTES/INDIVIDUALS

1. The Institute/Individual selected through this procedure will be responsible to establish a world class smart digital learning facility which will provide coaching guidance by means of coaching class, study materials etc. for the students of 11th and 12th standard aspiring for NEET/JEE.
2. The selected Institute /Individual should be of national repute and should provide highly educated teaching faculty with maximum numbers of IITians and NIITians and minimum 5 years' coaching experience in running such establishments.
3. 10% or minimum 100 seats whichever is higher will be reserved for wards of employees of Shri Sai Baba Sansthan trust shirdi and should be provided free of cost coaching facilities. However, the selection of the same should be done on merit only. An additional 5% reservation should be kept for the wards of suicide affected farmer's children, wards of single widow, wards who lost both the parents in covid pandemic, wards of war widows.
4. The Institute/Individual must provide details of successful candidates from centers all over India & Maharashtra if any, on official letterhead.
5. The establishment will be allowed to take fees from other civilian population at rates lesser and discounted than that of there other centers.
6. The approximate tuition fees (consolidated) should be clearly mentioned in the EOI inclusive of all the fees and Taxes. The establishment will not be allowed to hike any fees without prior permission of Shri Saibaba Sansthan Trust, Shirdi.
7. The Establishment will have to pay for the ancillary facilities, that is housekeeping and electricity charges separately to the Sansthan. The establishment will be responsible for the safety and security of the building & students.
8. Any dispute arising will be settle at jurisdiction of Rahata, Kopargaon & Aurangabad High courts
9. The Shri Sai Baba Sansthan Trust, Shirdi reserve the rights to visit and check the establishment at any time without giving any prior intimation.
10. The establishment should have all permission required to Run such a facility.
11. The premises will not be used for any Unauthorized purposes other than coaching classes.
12. The Shri Saibaba Sansthan Trust, Shirdi reserve the right to terminate the project at any point of time and the decision of Shri Saibaba Sansthan trust Shirdi will be final.
