- Bidder should have average annual financial turnover of value not less than Rs.5.65 Crores, during the last 03 financial years. Bidder will be required to submit the annual turnover certificate of last 03 financial years (FY-2014-2015, 2015-2016 & 2016-2017) issued by Chartered Accountant.
- 2) Bidder should have a solvency of value not less than Rs.2.50 Crores. The bidder will be required to submit the certificate, issued by the Bank.
- 3) The bidding capacity of the bidder should be equal to or more than the estimated cost of the work. The bidding capacity shall be worked out by the following formula: Bidding Capacity = A\*N\*2-B.

Where,

A = Minimum value of turnover of last 03 years.

N = Number of years prescribed for completion of work for (08 months).

B = Value of existing commitments and ongoing works to be completed during the period of completion of work.

## The bidders should workout the bidding capacity according to aforesaid formula and submit it along with the supporting documents.

- 4) The bidder should be registered with Employees Provident Fund Organization. The copy of registration should be attached.
- 5) The bidder should submit undertaking that he is not barred / blacklisted by any Client including State / Central Govt. Department / PSU's.
- 6) The bidder should submit his Arbitration / Litigation record. If the bidder has no such record, he should submit an undertaking accordingly.
- 7) Shri Saibaba Sansthan Trust, Shirdi reserves the right to disqualify any or all bidders without assigning any reasons therefor.
