B) Terms and Conditions:

- 1. The rates for above work shall be inclusive of GST, material, royalty, labour, transport etc. complete.
- 2. The bidder shall furnish the copy of GST Registration.
- 3. The rates quoted shall be firm & no escalation of rates will be entertained till completion of work after issue of work order.
- 4. Quantities in BOQ are approximate and may vary according to the requirement. Bill will be paid as per the measurement of actual work executed on site.
- 5. No advance payment will be given against the work order. Bill will be paid after submission of R. A. bill / Final Bill and as per the actual quantity executed on site.
- 6. 75% Advance will be payable on R. A. Bill. After certification of bill.
- 7. Value of Interim Bill Certificate is Rs.2,50,000/-.
- 8. The date of commencement shall be 07 days from date of issue of work order.
- The time for completion shall be 30 days from the date of commencement after issue of work order.
- 10. Material shall be strictly used as per the specifications and makes with prior approval of Sansthan.
- 11. Electricity required for the work shall be made available at one point by Sansthan.
- 12. Validity of quotation 90 days from last date for submission of sealed quotation and to be extended if required.
- 13. **Liquidated Damages** The liquidated damages to be recovered will be Rs.500/- per delayed day. The total amount of Liquidated damages / Penalty shall not exceed five percent (5%) of the total Contract amount.
- 14. The bidders are requested to submit their Bank details (RTGS) along with the quotation document.
- 15. Bidders are requested to submit the lowest rates for this work.
- 16. Royalties The Contractor shall indemnify the Client against all claims in respect of patent rights, and shall defend all actions arising from such claims, and shall themselves pay all royalties, license fees, damages, cost and charges of all and every sort that may be legally incurred in respect hereof.

 It is the responsibility of the contractor to pay the royalty charges to the concerned govt department as per the rules and regulations.
- 17. The contractor shall furnish the challans of royalty paid to concerned govt. department and the said amount shall be paid to Contractor by the Trust

Except the territorial jurisdiction of Shirdi prescribed by law, no other court is having jurisdiction over the matter. All legal claims should be within the jurisdiction of Rahata and Kopargaon Court.
