1.1 Scope of Work.

- 1) Supply, installation, testing and commissioning of supplied Garden Speakers & Others Sound System Accessories as per specification mentioned in Tender/Purchase order.
- 2) Provide product documentation, SOP, and operating training to SSST Sound Dept., employees.
- **3)** Successful Tenderer has to send their technician quarterly to inspect, adjust, and Rectify the Garden Speakers & Others Sound System Accessories, in 5 Years Compressive Warranty period.

2.0 Tender Fees, Earnest Money Deposit & Security Deposit:

- a) Earnest Money Deposit: -Rs: 95,000 (In Words Rs:-Ninety Five Thousand Only)

3.0 Security Deposit (SD): Successful bidder has to deposit 3% amount of awarded cost as security deposit within 15 days from acceptance of purchase order. This SD amount will be refunded after the completion of warranty period. No interest will be paid on the EMD and Security Deposit.

- 3. Bid specific Authorization letter from manufacture of the makes specified to be produced on the company letter head duly signed by the company Authority.
- 4. Letter stating that the Firm/Company is not blacklisted by Central / State Government, Government Corporation, statutory Institute. (on firm letter head)
- 5. Letter on company/Firm letter head Stating that "Company/Firm have read all terms and conditions and agree with them"
- 6. Fill and upload the "Annexure A, B and C".

4.2 Commercial Bid

- ❖ Quoted Price should be inclusive of all Taxes, packing, forwarding, loading and unloading expenses, all accessories with Garden Speakers, Installation and commissioning cost.
- ❖ No anyother expenses will be paid separately by the Sansthan.
- ❖ In future, if there is change in GST then it will be make applicable from the date of notification.

4.3 Acceptance of Tender:

- 1. Online Technical Bid will be opened on/05/2025 (If possible).
- 2. The commercial bid of technically qualified bidders shall only have opened online and lowest offer amongst the opened bid will be accepted. The acceptance of tender will be communicated to the bidder by email or otherwise.

5.0 Payments:

- 1. No advance will be given for the said supply.
- 2. 100% amount of order will be paid after supply, successful Installation/commissioning, of Garden Speakers & Others Sound System Accessories.
- 3. Applicable taxes will be deducted at source from bills at the prevailing rate.

6.0 Penalty:

1. If the Garden Speakers & Others Sound System Accessories are not supplied and installed as per the supply order within the time limit, liquidated damages are recovered as follows.

a) If the cost of supply order less than Rs. 2.00lakhs	%0.50 per week up to a maximum of %10
b) If the cost of supply order is above Rs. 2.00 lakhs or more	0.50 % per week up to a maximum of % 5

- 2. In case supply material is rejected because of it is not as per the supply order or not supply in specified time, the Sansthan shall be allowed to purchase the machinery from the market as per the market price and the excess amount (difference) for such purchased material shall be recovered from the Security Deposit or subsequent Bills.
- 3. If successful bidder refuses to deliver the Garden speaker systems & other sound system accessories or fails to deliver, EMD will be forfeited and bidder will be blacklisted for 3 years.
- 7.0 Warranty Period:-Comprensive Warranty period of Garden speaker systems & other sound system accessories is 5 years from the date of commissioning. Supplier should provide 24X7 online supports within warranty period. And should help our representative to log the call/Send E-mail with respective Bidder/Company/OEM. If supplier fails to resolve the issue in 48 hours from next business day, Rs.500/- will be deducted per week from security deposit until the issue is resolved.

8.0 Terms and Conditions:

- 1. The tenderer should quote rate as per the specification mentioned in tender.
- 2. Manufacturer/authorized dealer should not upload Unnecessary, foggy, unreadable, smudged documents for prequalification otherwise will be disqualified. All necessary documents should be attested and Uploaded in PDF Format only. Any kind of request or excuse will not be entertained related to inadequate or missed uploading.

- 3. Contractor should complete work as per specification in tender within 60 days from the date of PO.
- 4. The bidder should study all the tender documents carefully and understand the tender contract conditions, specifications etc. before quoting online. Also, the decision taken by the Sansthan will be binding on the Supplier. No complaint will be entertained in this regard.
- 9. Award of contract:-The Sansthan will award the contract to the successful contractor whose tender has been determined to be substantially responsive and has been determined as lowest evaluated tender. The Chief Executive Officer, SSST reserve the right to increase or decrease the quantity to be purchased and also reserves the right to cancel or revise or any of the all tenders or part of tenders without giving any reasons.
- 10. **Testing of materials :-** The engineer shall be entitled to have tests carried out as specified in IS for any materials supplied by the tenderer at the cost of work order.
- 11. Successful tenderer has to sign an agreement with the Sansthan on a stamp paper of Rs.100/- and pay the notary fee of the agreement. The work order along with the offer submitted by tenderer shall form the part of the contract documents
