1.	<p>Providing, Supplying and Fixing tensile fabric roof with fabric (Make - Serg Ferrari, Mehler Valmex) with white colour tensile polyester fabric of 750 Gsm coated with PVDF coating lacquer system on both sides, protected against microbial & fungai, UV-protected top coat of membrane type-2 grade and including necessary aluminium locking strips, screws, fastners etc. complete as specified and approved by Sansthan on the existing sheds at Shri Saibaba Hospital.</p> <p>The rates shall be inclusive of epoxy painting to existing structure, scaffolding, transport, wastage, GST, labour, all material, incidental charges, all fittings fixtures complete as per technical specification.</p> <p>Actual surface area of fabric will be measured at the time of billing.</p> <p>Epoxy painting shall be done by the bidder to the existing shed structure.</p> <p>(New PVDF coated fabric is to be fixed on the existing sheds at Shri Saibaba Hospital. - Fabric:** The Proposed fabric will be FR 702 S2.
Manufacturer's Warranty: 10 years. **Make of Fabric:** Ferrari, Mehlar of White Colour.
Material of the Fabric: PVDF Double coated.
- Structural Steel Paint: Finish:** Primer, Epoxy paint with 2 Coating Spray painting.
Paint: Berger / Asian / Jotun. **Colour Shade:** Off White.
- Site: Delivery & execution of the work shall be at Shri Saibaba Hospital, Shirdi.
- The rates for above work shall be inclusive of GST, all material, labour, transport, octroi, cess etc. complete.
- The bidder shall furnish the copy of GST Registration.
- The rates quoted shall be firm & no escalation of rates will be entertained till completion of work after issue of work order.

7. The date of commencement shall be 07 days from date of issue of work order.
8. Time for completion shall be 45 days from the date of commencement.
9. Quantity mentioned in BOQ is approximate and may vary according to requirement. Bill will be paid as per the measurement of work executed. Actual fabric area will be measured for the bill.
10. No advance payment will be given against the work order. Bill will be paid after submission of R. A. bill / Final Bill and as per the actual quantity executed on site.
11. 75% Advance will be payable on submission of R. A. Bill / Final Bill.
12. Value for Interim bill certificate will be Rs.2,00,000/-.
13. 5% Total Security Deposit will be recovered from the R. A. / Final bills. The total deposit will be returned after 12 months of Defects Liability Period. Defects Liability period will be for 12 months for above mentioned work.
14. Material shall be strictly used as per the specifications and makes with prior approval of Sansthan.
15. Electricity required for the work shall be made available at one point by Sansthan.
16. Validity of quotation - 90 days from last date for submission of sealed quotation and to be extended if required.
17. Liquidated Damages - The liquidated damages to be recovered will be Rs.500/- per delayed day. The total amount of Liquidated damages / Penalty to be paid under the provisions of this clause shall not exceed five percent (5%) of the total contract amount.
18. The bidders are requested to submit their Bank details along with the quotation.
19. Bidders are requested to submit the final lowest rates for this work on their own letterhead.
