MINIMUM QUALIFYING CRITERIA (SUMMARY)

- 1) Tender document fee Rs.3,540/- (Rs.3,000 + 18% GST) by online payment on www.mahatenders.gov.in.
- 2) EMD of **Rs.3,55,000/- (Rupees Three Lakh Fifty-Five Thousand only)** by online payment on www.mahatenders.gov.in.
- 3) Bidder should have satisfactorily completed at least two works of Similar Nature of estimated cost not less than Rs.700.00 Lakh (In Word – Rupees Seven Crore only) in last 03 financial years. (2023-24, 2024-25, 2025-26)
- 4) The Bidder should have average annual financial turnover of value not less than Rs.10.00 Crore (In Word – Ten Crore Only) during last 3 (Three) audited financial years (FY 2023-24, 2024-25, 2025-26)
- 5) Registration certificates with the Employees' Provident Fund Organization, GST and Professional Tax should be submitted along with the technical bid.
- 6) Ownership / hire of the key and critical equipment (hot mix plant with SCADA within 60 km of site, sensor paver, rollers, tippers, excavators, grader etc.) as specified in Clause 11.

7) **Bid Capacity**

The bidding capacity of the bidder should be equal to or more than the estimated cost of the work. The bidding capacity shall be worked out by the following formula:

Bidding Capacity = (A x N x 1.5) - B.

Where,

A = Maximum value of civil engineering works executed in anyone year during the last 05 years (updated to the price level of the year indicated in Appendix 'L') taking into account the completed as well as works in progress.

N = Number of years prescribed for completion of the works for which bids are invited (09 Months i.e. 0.75 years).

B = Value (updated to the price level of the year indicated in Appendix 'L') of existing commitments and on-going works to be completed during the next ... Years (Period of completion of works for which bids are invited).

Note: The statements showing the value of existing commitments and on-going works as well as the stipulated period of completion remaining for each of the works listed should be countersigned by the Engineer in Charge, not below the rank of an Executive Engineer or Architect / Consultant.

The bidders should workout the bidding capacity according to aforesaid formula and submit it along with the supporting documents.

- 8) Bidder should submit an undertaking that he is not barred / not blacklisted by any Client including State / Central Govt. Department/PSU's.
- 9) Bidder should submit Arbitration / litigation records. If the bidder has no such record, he should submit an undertaking accordingly.
- 10) Bidder should attach Geo-tagging photographs of site visit with the technical documents.
