- ❖ Bidder should have satisfactorily completed one work of similar nature or any building work of estimated cost not less than **Rs.30.14Lakhs** during last five years.

Bidder should have satisfactorily completed two works of similar nature or any building work of estimated cost not less than **Rs.18.83Lakhs** during last five years.

OR

Bidder should have satisfactorily completed three works of similar nature or any building work of estimated cost not less than **Rs.15.07Lakhs** during last five years
