- 1) The bidder should submit the cost of blank tender document Rs.590/- and EMD of Rs.30,000/- through online payment on www.mahatenders.gov.in.
- 2) The bidder should be registered as a contractor with PWD or any other Govt. dept. in appropriate class. The registration copy should be attached.
- 3) The bidder must have successfully completed the projects as below, during the last 05 financial years ending 31st March 2024. The bidder is required to submit its Work Order and Completion Certificate issued by the Clients.
 - 03 similar types of works or civil works whose estimated value is not less than 40% of the estimated amount of the project / tender. (i.e.- it shall more than Rs.12 lakhs each).

OR

• 02 similar types of works or civil works whose estimated value is not less than 50% of the estimated amount of the project / tender. (i.e.- it shall be more than Rs.15 lakhs each).

OR

- 01 similar type of work or civil work whose estimated value is not less than 80% of the estimated cost of the project / tender. (i.e.- it shall be more than Rs.24 lakhs).
- 4) The bidder should have a maximum annual financial turnover of at least Rs.30 lakhs, in any one year of the last 05 financial years, (FY-2019-20, 2020-21, 2021-22, 2022-23 and 2023-24). The bidder shall submit the certificate issued by the CA.
- The bidder should be registered with Employees Provident Fund Organization. The copy of EPF registration should be attached.
