- 1) Tender document fee Rs.600/- and EMD amount Rs.33,400/- shall be submitted through online payment on [www.mahatenders.gov.in](http://www.mahatenders.gov.in). Details of UTR no. should be uploaded online.
- 2) The bidder should be registered as a contractor with PWD or any other Govt. dept. in appropriate class. The registration copy should be attached.

**OR**

The bidder should have satisfactorily completed one work of similar nature or any other Civil work / RCC Structure work of estimated cost not less than Rs.25 Lakh, during last 5 years, ending on 31/03/2020.

- 3) The bidder should have average annual financial turnover of value not less than Rs.94 lakhs. Bidder will be required to submit the annual turnover certificate of last five financial years (FY-2014-2015, 2015-2016, 2016-2017, 2017-2018, 2018-2019) issued by the Chartered Accountant.

- 4) The bidder should be registered with Employees Provident Fund Organization. The copy of registration should be attached.
- 5) The bidder should be registered with GST Dept. The copy of registration should be attached.
- 6) The bidder should have sufficient number of technical staff for the proper execution of the work. The bidder should submit a list of these employees stating clearly who will be involved in this work, if work is awarded.
- 7) The bidder should submit the list of plants and construction equipments required for the proper execution of the work.
- 8) The bidder should submit undertaking that he is not barred / not blacklisted by any Client including State / Central Govt. Department/ PSU's.
- 9) The bidder should submit his Arbitration / litigation record. If the bidder has no such record, he should submit an undertaking accordingly.
