❖ Bidder should have satisfactorily completed one work of similar nature or any building work of estimated cost not less than **Rs.22.95Lakhs** during last five years.

Bidder should have satisfactorily completed two works of similar nature or any building work of estimated cost not less than **Rs.14.34Lakhs** during last five years.

OR

Bidder should have satisfactorily completed three works of similar nature or any building work of estimated cost not less than **Rs.11.48Lakhs** during last five years
