- ❖ The bidder should submit the cost of blank tender document **Rs.590/-** through Online payment on Government website www.mahatenders.gov.in.
- ❖ The bidder should submit the EMD of **Rs.23,500/-** through Online payment on Government website www.mahatenders.gov.in.
- ❖ Bidder should have satisfactorily completed One work of similar nature of estimated cost not less than **Rs.17.40Lakhs** or Two works of similar nature of estimated cost not less than **Rs.11.60Lakhs** during last five years.
- ❖ Bidder should have maximum annual financial turnover of value not less than **Rs.52Lakhs** during last five financial years. (2016-17, 2017-18, 2018-19, 2019-20, 2020-21). CA certificate should be attached.
- ❖ The bidder should be registered as a contractor with PWD or any other Govt. Department in appropriate class. The PWD registration copy should be attached.
- ❖ Bidder should submit undertaking that he is not barred / not blacklisted by any Client including State / Central Govt. Department/ Undertaking / PSU's.
- ❖ Bidder should submit Arbitration / litigation records.
- ❖ Bidder should submit GST Registration Certificate.
