MINIMUM QUALIFYING CRITERIA

- 1) Tender document fee Rs.3,540/- (Rs.3,000 +18% GST) by online payment on www.mahatenders.gov.in.
- 2) EMD of Rs. 15,13,000 /- by online payment on www.mahatenders.gov.in.
- 3) Joint venture not permitted.
- 4) Bidder should have satisfactorily completed at least one single work of Similar Nature of estimated cost not less than Rs.12.11Crores in last 05 financial years. (2018-19, 2023-20, 2020-21, 2021-22, 2022-23)

OR

Bidder should have satisfactorily completed two works of Similar Nature of estimated cost not less than Rs.7.57Crores each in last 05 financial years. (2018-19, 2023-20, 2020-21, 2021-22, 2022-23)

OR

Bidder should have satisfactorily completed three works of Similar Nature of estimated

cost not less than Rs.6.10 Crores each in last 05 financial years. (2018-19, 2023-20, 2020-21, 2021-22, 2022-23)

- 5) The Bidder should have an average annual turnover of minimum Rs.11.75 crores in last 5 (five) audited financial years (FY 2018-19, 2023- 20, 2020-21, 2021-22, 2022-23) Bidder should have a solvency of value not less than Rs.50 Crores. The bidder will be required to submit the bank certificate.
- 6) The bidder should be registered with Employees Provident Fund Organization. The copy of registration should be attached.
- 7) The bidding capacity of the bidder should be equal to or more than the estimated cost of the work. The bidding capacity shall be worked out by the following formula: Bidding Capacity = (A x N x 1.5) B. Where.
 - A = Maximum value of civil engineering works executed in anyone year during the last 05 years (updated to the price level of the year indicated in Appendix 'L') taking into account the completed as well as works in progress.
 - N = Number of years prescribed for completion of the works for which bids are invited (12 months).
 - B = Value (updated to the price level of the year indicated in Appendix 'L') of existing commitments and on-going works to be completed during the next ... Years (Period of completion of works for which bids are invited).

Note: The statements showing the value of existing commitments and on-going works as well as the stipulated period of completion remaining for each of the works listed

should be countersigned by the Engineer in Charge, not below the rank of an Executive Engineer or Architect / Consultant.

The bidders should workout the bidding capacity according to aforesaid formula and submit it along with the supporting documents.

- 8) The bidder should have sufficient number of technical staff for the proper execution of the contract. The bidder should submit a list of these employees stating clearly whom out of these are likely to be involved in this work, if work is awarded.
- 9) Bidder should name management person who would be available for deliberation of the project during execution and would be available in critical review meetings.
- 10) Bidder should submit an undertaking that he is not barred / not blacklisted by any Client including State / Central Govt. Department/ PSU's.
- 11) Bidder should submit Arbitration / litigation records. If the bidder has no such record, he should submit an undertaking accordingly.
