11) MINIMUM QUALIFYING CRITERIA:

The following copies of original / attested documents should be scanned & uploaded online.

- 1) Tender document fee Rs.11,800/- by online payment on www.mahatenders.gov.in.
- 2) EMD of Rs.83,00,000/- by online payment on www.mahatenders.gov.in.
- 3) Bidder should have satisfactorily completed atleast one work of any similar RCC framed structure with PT slab of estimated cost not less than Rs.67 Crores in last 03 financial years (FY-2015-2016, 2016-2017 and 2017-2018).
- 4) Bidder should have completed works having RCC PT Slab area totalling to a minimum of 12000 Sqm till the date of submission of bid.

- 5) Bidder should have average annual financial turnover of value not less than Rs.83 Crores. Bidder will be required to submit certified and audited balance sheets and the avg. annual turnover certificate of 03 financial years (FY-2014-2015, 2015-2016, 2016-2017) issued by Chartered Accountant.
- 6) Bidder should have a solvency of value not less than Rs.25 Crores. The bidder will be required to submit the bank certificate.
- 7) The bidder should be registered with Employees Provident Fund Organization. The copy of registration should be attached.
- 8) The bidding capacity of the bidder should be equal to or more than Rs.83 Crores. The bidding capacity shall be worked out by the following formula: Bidding Capacity = A*N*2-B.

Where,

A = Maximum value of RCC building work or any civil construction works executed in any one year during the last 03 years taking into account the completed as well as works in progress.

N = Number of years prescribed for completion of work for which applications are invited (12 months).

B = Value of existing commitments and ongoing works to be completed during the period of completion of work.

The bidders should workout the bidding capacity according to aforesaid formula and submit it along with the supporting documents.

- 9) The bidder should own construction equipments required for the proper and timely execution of the work. The bidder should submit the current usage of owned construction equipments stating name of projects. If number of owned equipments meet the requirement but are unlikely to be available for this project, then bidder should submit plan for hiring construction equipment.
- 10) The bidder should have sufficient number of technical staff for the proper execution of the contract. The bidder should submit a list of these employees stating clearly whom out of these are likely to be involved in this work, if work is awarded.
- 11) Bidder should name management person who would be available for deliberation of the project during execution and would be available in critical review meetings.
- 12) Bidder should submit an undertaking that he is not barred / not blacklisted by any Client including State / Central Govt. Department/ PSU's.
- 13) Bidder should submit Arbitration / litigation records. If the bidder has no such record, he should submit an undertaking accordingly.
- 14) Shri Saibaba Sansthan Trust, Shirdi reserves the right to disqualify any or all bidders without assigning any reasons therefor.
