- ❖ The bidder should submit the cost of blank tender document **Rs.590/-** through Online payment on Government website www.mahatenders.gov.in.
- ❖ The bidder should submit the EMD of **Rs.19,500/-** through Online payment on Government website www.mahatenders.gov.in.
- ❖ Bidder should have satisfactorily completed One work of similar nature of estimated cost not less than **Rs.15.04Lakhs** or Two works of similar nature of estimated cost not less than **Rs.9.40Lakhs** or Three works of estimated cost not less than **Rs.7.52Lakhs** during last five years.
- ❖ Bidder should have maximum annual financial turnover of value not less than **Rs.42.31Lakhs** during last five financial years. (2015-16, 2016-17, 2017-18, 2018-19, 2019-20). CA certificate should be attached.
- ❖ The bidder should be registered as a contractor with PWD or any other Govt. Department in appropriate class. The PWD registration copy should be attached.
- ❖ Bidder should submit undertaking that he is not barred / not blacklisted by any Client including State / Central Govt. Department/ Undertaking / PSU's.
- ❖ Bidder should submit Arbitration / litigation records.
