

2. The rate should be inclusive of GST , Transport, Packing & forwarding charges.
3. Rate quoted by you in tender will be final.
4. No advance payment if any case would be made. 100% payment will be made after 15 days from the date supply of material at Shirdi Site.
5. **Security Deposite** :- 5% of order value will be deposit in Sansthan account office at the time of acceptance of work order. It will be refundable after 6 months from the last date of supply of all spare parts. No interest will be paid on security deposit.
6. **Time Period** :- The total material shall be supplied within 15 days from the date of purchase order.
7. The Tenderer shall submit the offer sealed envelope. An envelope should be clearly attached & superscripted as “**Mechanical Department - Supply of spare parts of Reverse Osmosis of Shri Saibaba Sansthan Trust, Shirdi.**” Quotation submitted to inward office of Sansthan on or before dated 24/06/2021
8. **Penalty** :- For delay for supply of material vendor shall be liable to pay the client as a penalty Rs. 500 per day. In any event maximum amount of penalty shall not exceed 5% of order value.
9. The spare parts should be as per specification. No other technical specification or company will be acceptable. Duplicate, inferior spare parts will be rejected by Sansthan
10. In case of any dispute the same will be subject to the jurisdiction of the compliant court at RAHATA.
