2. Validity:

14. Warranty :

- (a) The Tenderers must include 02 years comprehensive on-site warranty (Including all Spares, Accessories and Labour) from the date of completion of the satisfactory installation. And also Comprehensive Defects Liability Period Maintenance must be minimum 03 years after Comprehensive on-site Warranty. The warranty and Comprehensive Defects Liability Period Maintenance charges shall not be quoted separately otherwise the offer shall be summarily rejected. Failure to comply this condition will entail the rejection of the bids.
- (b) No offer of the vendor will be accepted without warranty/ guarantee of their supplied/ installed goods.
