MINIMUM QUALIFYING CRITERIA

The following copies of original / attested documents should be scanned & uploaded online along with technical bid documents.

- 1) Tender document fee Rs.2,360/- (Rs.2,000 +18% GST) by online payment on www.mahatenders.gov.in.
- 2) EMD of Rs.1,50,000/- by online payment on www.mahatenders.gov.in.
- 3) Joint venture not permitted.
- 4) Bidder should have satisfactorily completed and operated successfully one Biomethanation Plant with allied works of similar nature of estimated cost not less than Rs.1.31Crores during last five years ending on 31/05/2019.
- 5) Bidder should have average annual financial turnover of value not less than Rs.5.22Crores. Bidder will be required to submit certified and audited balance sheets and the avg. annual turnover certificate of last 05 financial years issued by Chartered Accountant. (2013-14, 2014-15, 2015-16, 2016-17, 2017-18).
- 6) The bidder should be registered with Employees Provident Fund Organization. The copy of registration should be attached.
- 7) The bidding capacity of the bidder should be equal to or more than the estimated cost of the work. The bidding capacity shall be worked out by the following formula:

Bidding Capacity = A*N*2-B. Where,

- A = Maximum value of similar works executed in anyone year during the last 05 years taking into account the completed as well as works in progress.
- N = Number of years prescribed for completion of the works for which bids are invited (6 months).
- B = Value of existing commitments and on-going works to be completed during the Period of completion of works for which bids are invited.

Note: The statements showing the value of existing commitments and on-going works as well as the stipulated period of completion remaining for each of the works listed should be countersigned by the Engineer in Charge, not below the rank of an Executive Engineer or Architect / Consultant.

The bidders should workout the bidding capacity according to aforesaid formula and submit it along with the supporting documents, viz. copies of work orders and completion certificates.

- 8) Bidder should submit an undertaking that he is not barred / not blacklisted by any Client including State / Central Govt. Department/ PSU's.
- 9) Bidder should submit Arbitration / litigation records. If the bidder has no such record, he should submit an undertaking accordingly.

Shri Saibaba Sansthan Trust, Shirdi reserves the right to disqualify any or all bidders without assigning any reasons therefor.
