MINIMUM QUALIFYING CRITERIA

- 1) e-Tender form fee of Rs.1,180/- should be paid through online payment on www.mahatenders.gov.in. The amount paid by the bidder as an e-Tender form fee is non-refundable.
- 2) Earnest Money Deposit (EMD) amount of Rs.1,88,000/- should be paid through online payment on www.mahatenders.gov.in. No interest shall be payable by the

Trust on the amount deposited by the bidder as an EMD.

- 3) The bidder should be a Proprietary firm /Partnership firm/Private Limited/Limited Company/Corporate body legally constituted or Limited Liability Partnership Firm and should be registered with the appropriate registration authority in India.
- 4) The bidder should be the valid licensee of Bhabha Atomic Research Centre (BARC) for Hybrid Granular SBR Treatment (GST) technology and should submit the copy of agreement with BARC for the technology transfer to that effect. OR The bidder should submit an undertaking that he will obtain the requisite license from BARC and submit the copy of agreement with Bhabha Atomic Research Centre (BARC) for technology transfer of Hybrid Granular SBR Treatment (GST) technology, in case he is being the successful bidder, within 45 days from the date of opening of commercial bids. Failing to do so, his Earnest Money Deposit will be forfeited by the Trust.
- 5) The bidder must have successfully completed works of STPs/ETPs as mentioned below, during the last 5 years ending 31st December 2024. The bidder should submit its work orders and completion certificates issued by the clients, along with photographs of the works completed.
 - a) Three works of STPs/ETPs costing not less than Rs.75 Lakhs each OR
 - b) Two works of STPs/ETPs costing not less than Rs.94 Lakhs each OR
 - c) One work of STPs/ETPs costing not less than Rs.150 Lakhs.
- 6) The bidder should have an annual financial turnover not less than Rs.125 Lakhs, in any one financial year of last 05 financial years (FY 2019-20, 2020-21, 2021-22, 2022-23 and 2023-24). The bidder should submit the turnover certificate issued by the Chartered Accountant for the aforesaid financial years.
- 7) The bidder should be registered with Goods and Services Tax. The copy of GST Registration and PAN card should be attached.
- 8) The bidder should be registered with Employees Provident Fund Organization. The copy of EPF registration should be attached.
- 9) The bidder should submit an undertaking that it is not barred/ not blacklisted by any Client including Government/ semi Government/ Public sector unit/ Local statutory bodies etc.
- 10) The bidder should submit its Arbitration/ Litigation record. If the bidding firm had no such record, it should submit an undertaking accordingly.
- 11) The bidder should submit the list of technical staff along with their designation, qualification, experience and their availability for this project.
