- 1) e-RFP form fee of Rs.1,180/- should be paid by online payment on www.mahatenders.gov.in. The amount paid by the bidder as an e-RFP form fee is non-refundable.
- 2) Earnest Money Deposit (EMD) amount of Rs.1,00,000/- should be paid by online payment on www.mahatenders.gov.in. No interest shall be payable by the Sansthan on the sum deposited by the bidder as an EMD.
- 3) Should be a Proprietary firm /Partnership firm/Private Limited/Limited Company/Corporate body legally constituted or Limited Liability Partnership Firm and should be registered with the appropriate registration authority in India.
- 4) Should have at least TEN years (from 01/01/2014) of working experience in Water Sector as a PMA/PMC/PMU for any Government/ semi Government / Public sector unit / Local statutory bodies.
- 5) Should have minimum financial average annual turnover of Rs.50 Lakh, during last 03 financial years (FY 2020-2021, 2021-2022 and 2022-2023) based on audited financial statements, Profit & Loss statement and the certificate issued by the Chartered Accountant.

- 6) Should fulfill any one of the following experience criteria from 1st April 2018 onward. (a) Should have completed consultancy services in similar water supply scheme /project total costing not less than Rs.40 Crore for any Government/ semi Government / Public sector unit / Local statutory bodies' in ONE assignment. OR (b) Should have completed consultancy services in similar water supply scheme /project total costing not less than Rs.25 Crore EACH for any Government/ semi Government / Public sector unit / Local statutory bodies' in TWO assignments. The consulting firm should submit its LOI / LOA / Work Order and its Completion Certificate issued by the Clients.
- 7) Should submit the list of technical staff along with their designation, qualification, experience and their availability for this assignment.
- 8) Should have registered with Goods and Services Tax. The consulting firm should submit copies of GST Registration and PAN card.
- 9) Should submit an undertaking that it is not barred / not blacklisted by any Client including Government/ semi Government / Public sector unit / Local statutory bodies'.
- 10) Should submit its Arbitration/ Litigation record. If the consulting firm had no such record, it should submit an undertaking accordingly.
