Providing and laying Vitrified MATT finish having decorative type of size 1800 millimeter x1200 millimeter of 8 to10 millimeter thickness (for Dado) with bonding chemical and confirming to IS 15622-2006 (Group Bla) of approved make shade and pattern for Dado in required position laid on a bed of bonding chemical filling joints curing and cleaning etc. complete 4. Including green marble moulding Patti at top level. including all labour, adhesive, grout, water, all required material and necessary equipment etc. complete.	150	Sq. m.

1. Only vitrified tiles of size 1800 mm x 1200 mm will be provided by Sansthan without any cost. All other material & labour related expenses is bidder's responsibility.
2. The above rates shall be for completed item inclusive of GST and transport. The rates once quoted shall be firm & no escalation of rates will be entertained.
3. The Successful bidder has to Earnest Money Deposit - Rs.5,000/- by Cash/D.D. within 7 days of date of work order. Balance SD will be recovered from RA Bill. Total SD - 5% of Contract amount. SD will be released after 3 months after date of completion of work.
4. Quantities are approximate and may vary according to requirement. Bill will be paid as per the actual work done.
5. No advance will be paid against work order. Bill will be paid after completion of all work and upon submission of GST invoice bill.
6. The time for completion of work shall be 01 Month from the date of issue of the work order.
