The offer of the bidder shall remain valid for acceptance for a minimum period of **120 days** from the last date of online tender submission.

1.1 Scope of Work

- 1) Supply, installation, testing and commissioning of supplied machines as per specification with Civil, Electrician and mechanical works.
- 2) Provide product documentation, Lay out, Assembly and circuit diagrams as SOP, and Operating training to SSST employees.
- 3) Successful Tenderer has to send their technician Quarterly to inspect, adjust, rectify the Machines Problem or maintenance with free of cost with in warranty period.
- 4) In addition to the Quarterly visit technician has to attend all breakdown call.
Assurance to supply spare parts for next 10 years.

2.0 Tender Fees, Earnest Money Deposit & Security Deposit -

- a) Earnest Money Deposit - Rs: 95,000/- (Ninety Five Thousand Only)
- b) Tender Cost: - Rs: 5,700/- (Five Thousand Seven Hundred Only)

3.0 Security Deposit (SD) : Successful bidder has to deposit 5% amount of awarded cost as security deposit within 15 days from acceptance of purchase order. This SD amount will be refunded after warranty period. No interest will be paid on the EMD and Security Deposit.

Note:

1. The amount of EMD will be refunded back to all bidders (except L1 bidder) after issuing purchase order to L1 bidder.
2. L1 bidder's EMD amount will be refunded after deposit of Security Deposit by bidder.
3. Exemption of tender fee and security deposit under MSME is not applicable to this tender. All the tenderers are required to pay the tender fee and security deposit.
4. Even though the bidders meet the requirements, they are subject to be disqualified in case of misleading or false representations in the forms, statements and attachments submitted in proof of the qualification requirements.
5. Successful L1 Bidder has Provide Non – Judicial Stamp paper and Notary fee for Legal Agreement between bidder and SSST.

4.0 TENDERING PROCEDURE

4.1 Technical Bid

Technical BID must submit online only.

Scanned copy of following documents must be uploaded as Technical - bid.

1. Latest Shop Registration Certificate/ Certificate from Local Self-Government Body/ Similar Government License in the name under which tender is to be submitted.
2. Certificate of GST Registration and PAN, in the name under which E-tender is to be submitted.
3. Scanned copy of the average annual turnover certificate of last 3 financial years issued by Chartered Accountant. The average annual turnover of the Agency shall not be less than Rupees 25 Lakhs in the last three financial years. (2022-23, 2023-24, 2024-25)
4. Letter stating that the Firm/Company is not blacklisted by Central / State Government, Government Corporation, statutory Institute. (on firm letter head)
5. Letter on company/Firm letter head Stating that "Company/Firm have read all terms and conditions and agree with them"
6. Fill and upload the 'Annexure A, B and C.

4.2 Commercial Bid

- ❖ Quote Price should be inclusive of all Taxes, packing, forwarding, loading, unloading, Transporting with Transit Insurance expenses, all accessories with machines, Installation and training cost.
- ❖ No other expenses will be paid separately by the Sansthan.
- ❖ In future, if there is change in GST then it will be make applicable from the date of notification.

4.3 Acceptance of Tender :

1. Online Technical Bid will be opened on 15 / 10 /2026 (If possible)
2. The commercial bid of technically qualified bidders shall only have opened online and lowest offer (Set wise) amongst the opened bid will be accepted. The acceptance of tender will be communicated to the bidder by email.

5.0 Payments :

- 1) No advance will be given for the said supply.
- 2) 80% amount of order will be paid after supply, successful Installation / commissioning, of all machines.
- 3) 20% remaining amount will be paid after the training given to the Sansthan employees and after completing the warranty period.
- 4) Applicable taxes will be deducted at source from bills at the prevailing rate.

6.0 Penalty :

1. If the machineries are not supplied and installed as per the supply order within the time limit, liquidated damages are recovered as follows.

a) If the cost of supply order over than Rs. 5.00 lakhs	0.50% per week up to a maximum of 10% from the last date of supply period which is mentioned in P.O.
b) If the cost of supply order is less than Rs. 5.00 lakhs	0.50% per week up to a maximum of 5 % from the last date of supply period which is mentioned in P.O.

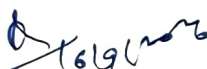
2. In case supply material is rejected because of it is not as per the supply order or not supply in specified time, the Sansthan shall be allowed to purchase the machinery from the market as per the market price and the excess amount (difference) for such purchased material shall be recovered from the Security Deposit or subsequent bills of L1 Bidder.

3. If successful bidder refuses to deliver the machinery or fails to deliver, EMD will be forfeited and bidder will be blacklisted for 3 years.

7.0 Warranty Period - Warranty period of machines is 2 years from the date of commissioning. Supplier should provide 24X7 online supports within warranty period. And should help our representative to log the call with respective company/OEM. If supplier fails to resolve the issue in 48 hours from next business day, Rs.1000/- will be deducted per week from security deposit until the issue is resolved.

8.0 Terms and Conditions:

1. The bidder should study all the tender documents carefully and understand the tender contract conditions, specifications etc. before quoting online. If there are any doubts, they should get clarifications in Pre - Bid meeting only this shall not be a justification for submission of late tender or extension of submission date.
2. The Tenderer should not submit documents other than called in tender.



3. All Bidders are mandatory to remain present to clear their Technical doubts in Pre – Bid mitting which will be held by SSST.
4. After attending technical Bid there is no doubts accept by SSST.
5. It is mandatory to supply and install machinery as per the sanctioned rate & Specification as per Supply Order. The supplier shall not have the right to ask for any increase in the sanctioned rate for any reason or such price hike will not be given. If the supplier refuses to supply the material or does not supply the material, the Sansthan has to purchase the material at the market price and the compensation for the excess cost will be recovered from the Supplier. Also, the decision taken by the Sansthan will be binding on the Supplier. No complaint will be entertained in this regard.
6. The machinery quoted should be ISI standard code may be whatever available.
7. Successful tenderer has to sign an agreement with the Sansthan on a stamp paper as per contract value and pay the notary fee of the agreement. The work order along with the offer submitted by tenderer and acceptance Letter of bidder. Shall form the part of the contract documents.

9. Each of the tender documents uploaded in technical bid is required to sign by the Authorised person/persons submitting the tender.
10. Conditional tenders will be rejected.
11. Shree Saibaba Sansthan Trust reserves the rights to any changes, amendments in the tender or accept / reject partial / Full Tender.
12. Force majeure clause of Law is liable to successful bidder as well as SSST.
13. Successful Tenderer should arrange their Technical Staff or labour lodging and boarding with his own cost.
14. Successful bidder has binding for labour Safety and labour laws.
15. All Tools Tackles lifting arrangement, lubricants consumable items, wiring, and foundation civil work done by successful bidders only within time.

9.0 Delivery Schedule

1. Successful bidder should supply the machinery within 16 weeks from the purchase order date. Bidder should complete the Installation/commissioning/training within 2 Month from the machinery delivery date. In total, bidder can manage the delivery and installation, commissioning, training 8 weeks from purchase order date.
2. The machinery will be inspected for acceptance in the presence of supplier representative and will be accepted if it is confirming to the specification mentioned in the Annexure D.
3. In case of rejection for not confirming/matching as per supply order specification the same will be sole responsibility of the supplier to make arrangement to collect the same at his own cost and risk immediately
4. Delivery of machinery to be done at Shree Saibaba ITI Department, Shree Saibaba Sansthan Trust, Shirdi on working day between 10 am to 6 pm.
